**Subject : The simplified customs corridor**

**Dear Mr. Ayyildiz!**

**We testify the respect to Embassy of Turkish Republic in the Russian Federation and would like to inform on a following question.**

**FCS OF RUSSIA, since March, 1st, 2019 within the reforming system of customs bodies of the Russian Federation started to operate the Aviation Center of Electronic Declaring (region of activity of Sheremetyevo customs). At the initial stage concentrates declarations concerning the goods moved through the airports of the Moscow aviaunit.**

**In this connection FCS OF RUSSIA made the decision to concentrate since June, 5th, 2019 in Aviation customs post (the center of electronic declaring) Sheremetyevo customs declaring of the goods occurring and imported into the Russian Federation from Turkish Republic by air transport within the limits of the Russian-Turkish project «the Simplified customs corridor» (further - SCC) is accepted.**

**FCS OF RUSSIA actualized the list of customs bodies in which realization SCC is provided, with following changes:**

- The Customs post the airport of the Sheremetyevo (cargo) is added in the specified list for fulfilment of the customs operations connected with arrival of the goods within the project of SCC;**

- The Aviation customs post (the center of electronic declaring) Sheremetyevo customs is included in the list for fulfilment customs operations within the project of SCC;
- Vnukovo custom is excluded from the list of customs bodies of declaring and release of the goods, thus in it the customs operations connected with arrival of the goods within the project of SCC;
- OTO-TK №2 Obninsk customs posts of the Kaluga customs and OTO-TK №2 Novozibkovo customs post of Bryansk customs are excluded from the list of customs bodies of declaring and release of the goods.

Considering importance of the given question, we ask to send the updated list of the Russian customs bodies participating in SCC to the Ministry of Trade of Turkish Republic.

Also we shall be extremely grateful, if you officially confirm reception of the specified list by our Turkish colleagues.

We take an opportunity to renew to Embassy of Turkish Republic in the Russian Federation assurances of the high respect.
